Your objects at the time of switching 31.12.2022

Hello,

Thanks to your support, we were able to successfully record the gas changeover in a first step.

The list on the back contains

- Objects assigned to you that will be taken into account at the above-mentioned switching time and
- all recorded gas appliances per object.

Important: The changeover does not take place on a district basis, but is based on the technical specifications of the gas network. It is therefore possible that neighboring properties will be adjusted at different times. If properties are missing, they will fall into a different switching district and you will be contacted again by us.

Please check the device specifications for completeness and report any discrepancies to us immediately via the free service number 0800.36372489 or by e-mail to info@mein-h-gas.de. Gas appliances not recorded by us cannot be adjusted. This leads to delays and additional work for us and for you. In the worst case, we may have to shut off a gas appliance/the gas connection on the adjustment date to avert danger.

What is the next step?

The following procedure is possible:

1. The adjustment is taken over by enercity Netz GmbH.
2. The manufacturer/dealer takes over the adjustment.
3. Your contract installation company takes care of the adaptation.
4. Your device adapts itself (self-adapting). No further steps are necessary.
The gas conversion has already been completed for this device.
5. Your device adapts itself (self-adapting). Since a defect was detected a new test is performed by enercity Netz GmbH.

Please refer to the device list to find out which procedure (1 - 5) is planned for a gas device.
