Thanks to your support, we were able to successfully record the gas conversion in a first step. The list on the reverse contains all the gas appliances that we have registered at your site. Please check them and report any discrepancies to us immediately by calling the free service number 0800.36372489 or by sending an e-mail to info@mein-h-gas.de. Gas appliances not recorded by us cannot be adjusted. This leads to delays and additional work for us and for you. In the worst case, we may have to shut off a gas appliance/the gas connection on the adjustment date to avert danger.

What is the next step?

The following procedure is possible:

1. The adjustment is taken over by enercity Netz GmbH.
2. The manufacturer/dealer takes over the adjustment.
3. The adaptation is carried out by a contract installation company.
4. Your device adapts itself (self-adapting). No further steps are necessary.
Gas conversion is already completed for this device.
5. Your device adapts itself (self-adapting). Since a defect was detected in the detection, a new test is performed by enercity Netz GmbH.

Please refer to the device list to find out which procedure (1. - 5.) is planned for a device.

If several gas appliances have been registered in your household, you may receive a separate appointment. This is due to the different technical requirements and adjustment times for each appliance. Of course, we try to keep the effort for you as low as possible and, if possible, adjust all gas appliances on one date.

What else can you do?

Please support us by ensuring the technically perfect condition and access to your gas appliances. Only then can an adjustment be carried out.
