Reminder: Appointment for the adjustment of your gas appliances

Hello,

we would like to remind you about the date of adjustment of your gas appliances. For this purpose our technician will visit you on:

Please allow a maximum of 60 minutes per gas appliance for the adjustment work in addition to the travel time mentioned.

Please keep the adjustment date. Perhaps neighbors or friends can also support you if you are unable to attend. Due to technical requirements, we cannot offer you another appointment. If you cannot keep the appointment under any circumstances, call the free service number 0800.36372489 as soon as possible.

Important notice

For safety reasons, we are obliged to adjust your gas appliances within a strictly specified time window. If we do not succeed in arranging a joint appointment within the scheduled period, we will have to initiate further measures, up to and including **blocking your point of consumption**, for safety reasons and to avert danger to life and limb.

What else can you do?

Please assist us by making the gas meter and gas appliances accessible. In addition, for liability reasons, the gas appliances must be both ready for operation and in operation on the adjustment date. Otherwise, there is a risk of a defect. If possible, also have the gas appliance manufacturer's instruction manuals, technical descriptions and maintenance instructions available. The adjustment usually involves replacing some parts, such as a gas nozzle. Here you do not have to worry about anything. We will bring the appropriate spare parts and install them professionally. To ensure a safe operating condition, we also carry out an exhaust gas measurement. Both processes are documented by photos, among other things.
